

Primary energy use

Environmental impact of this property

By making the <u>recommended changes</u>, you could reduce this property's CO2 emissions by 5.0 tonnes per year. This will help to protect the environment.

How to improve this property's energy performance

Making any of the recommended changes will improve this property's energy efficiency.

If you make all of the recommended changes, this will improve the property's energy rating and score from F (27) to A (93).
